The governing board will co-ordinate regular meetings with appropriate staff to discuss online safety, requirements for training, and monitor online safety logs as provided by the designated safeguarding lead (DSL).

The governing board should ensure children are taught how to keep themselves and others safe, including keeping safe online.

The governing board must ensure the school has appropriate filtering and monitoring systems in place on school devices and school networks and will regularly review their effectiveness. The board will review the DfE filtering and monitoring standards, and discuss with IT staff and service providers what needs to be done to support the school in meeting those standards, which include:

Identifying and assigning roles and responsibilities to manage filtering and monitoring systems.

Reviewing filtering and monitoring provisions at least annually.

- > Their rights, responsibilities and opportunities online, including that the same expectations of behaviour apply in all contexts, including online.
- > About online risks, including that any material someone provides to another has the potential to be shared online and the difficulty of removing potentially compromising material placed online.
- > Not to provide material to others that they would not want shared further and not to share personal material which is sent to them.
- > What to do and where to get support to report material or manage issues online
- > The impact of viewing harmful content
- > That specifically sexually explicit material (e.g., pornography) presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others and negatively affect how they behave towards sexual partners.
- > That sharing and viewing indecent images of children (including those created by children) is a criminal offence that carries severe penalties including jail.
- > How information and data is generated, collected, shared and used online
- > How to identify harmful behaviours online (including bullying, abuse or harassment) and how to report, or find support, if they have been affected by those behaviours
- > How people can actively communicate and recognise consent from others, including sexual consent, and how and when consent can be withdrawn (in all contexts, including online)

The safe use of social media and the internet will also be covered in other subjects where relevant.

Where necessary, teaching about safeguarding, including online safety, will be adapted for vulnerable children, victims of abuse and some pupils with SEND.

The school will raise parents/carers' awareness of internet safety in the weekly online safety blog via our website, and letters or other communications home. This policy will also be shared with parents/carers.

Online safety will also be covered during parents' visits and coffee mornings and training.

The school will let parents/carers know:

- > What systems the school uses to filter and monitor online use
- > What their children are being asked to do online, including the sites they will be asked to access and who from the school (if anyone) their child will be interacting with online

If parents/carers have any queries or concerns in relation to online safety, these should be raised in the first instance with the headteacher and/or the DSL.

Concerns or queries about this policy can be raised with any member of staff or the headteacher.

#### **Definition**

Cyber-bullying takes place online, such as through social networking sites, messaging apps or gaming sites. Like other forms of bullying, it is the repetitive, intentional harming of 1 person or group by another person or group, where the relationship involves an imbalance of power. (See also the school behaviour support policy & procedure.)
